## ADOPTING A CHILD FROM FOSTER CARE

In Florida, there are about 16,000 children in foster care and an estimated 500 of them are eligible and currently waiting to be adopted into safe, permanent homes. As victims of abandonment, abuse or neglect, these young people are placed in care because their birth family is unable or unwilling to provide a safe environment for them. The majority are healthy children who simply need and deserve a permanent, loving home. In Brevard County, Camelot Community Care works in partnership with Brevard Family Partnership (BFP) to find these children their forever families and homes.

Children waiting in the foster care system vary in age, from infants to young adults and many have siblings with whom they should stay with if and when possible. Some children have medical challenges and other special needs that are often treatable. Support and resources are available to help. It is a fact that children waiting for adoption

have had a disruptive home life and have frequently experienced significant trauma. They've been separated from their birth parents – and often from siblings or extended family – through no fault of their own, and they're often left with feeling of loss and grief and a fear of rejection. They are eager to belong. But they may doubt themselves because of past experiences, or they may be suspicious of new adults entering their lives.

It will be important to create a welcoming environment so that the child feels comfortable discussing thoughts and feelings with you, and provide the behavioral and psychological support they need.

## WHO CAN ADOPT, COST, & HOW LONG DOES IT TAKE?

To be eligible to adopt one of the children currently available, you may be married or single, already a parent or never a parent, in your 60s or in your 20s, an apartment renter or a homeowner, a person of modest means or wealth. The fact is that there is no one description of people who can be prospective adoptive parents.

Adopting from foster care comes with no cost. Contrary to common misconceptions, the adoption process through our dependency system is completely free of charge.

The process to become an approved adoptive parent includes attending a specialized training course, obtaining background, employment and reference checks, NTDC training, current physical exam, and completion of a home study.

The process usually can be completed in six to eight months.
